- The Seasons Lodge (560 State Rd 46) will be the host hotel for lodging, the car show and the awards dinner. Reservations should be made directly with the hotel at 1-800-365-7327 and mention the Midwest Z Heritage to receive the group rate. Rooms are limited so book early. As an alternate, the Brown County Inn is just down the road (1-800-772-5249).
